

Privacy Policy

1. Introduction

Thank you for visiting Prizenet and choosing our service. We strive to make our privacy policy easy to understand so that you are aware of how we use your information. This Privacy Policy, along with our Terms of Service, is an integral part of using our service. Therefore, you must fully agree to our privacy policy in order to use our service. If you are under the age of 14, please stop using our service immediately.

2. Collecting information

Identification of information collected from you:

When using our service, you will need to provide your name and account information from any of the four social networks (Facebook, Instagram, Twitter, TikTok). We may collect any information that you make available on your account in these social networks.

Unidentified information:

Whenever you visit our site, we may collect unidentified information from you, such as your IP address, interactions with the site and the service, URL links, information about the browser, operating system, cookies, data transmitted, and Internet provider. Without a legal requirement, this information cannot be used to identify you.

3. Use of your information
